## INSTRUCTIONS TO THE CANDIDATES APPEARING AT THE ADMISSION TEST

1. Produce the **Admit Card** during the Test on demand.
2. The Hall shall open 15 minutes before the commencement of examination. Examinees must bring their own ball pen/ pencil/eraser. No paper or material other than **Admit Card** shall be allowed to be in possession of the candidates during the examination.
3. Candidates are not allowed to leave the Hall during the period of Test. Temporary absence from the Hall is not ordinarily permissible. However, only after completion of one hour from the commencement of the Test, a candidate may be allowed under extraordinary circumstances to leave the hall temporarily for not more than three minutes with the permission of the Centre Superintendent.
4. Candidates should write only on the answer sheet supplied and should not make note on any other paper. While answering, they must use blue/black ballpoint pens only. Change of ink/pen is not allowed.
5. Candidates are not allowed to leave any identifying marks(s) anywhere on the answer sheet other than those required at specified places. Violation of this rule shall amount to adopting unfair means. Resort to any such unfair means or soliciting help from co-examinees or any other person or misbehaviour of any kind will automatically disqualify the candidate. For this purpose the report of the Invigilator/Examiner is sufficient.
6. For any other rules not provided for in these instructions the decision of the Course Coordinator/Head of the Department/ Chairman, P.G Council shall be final and binding.
7. If you have submitted Mark Sheet in grade scale produce immediately the equivalent marks from the institution, which has issued that mark sheet.
