2. Accordingly sealed quotations are invited for the disposal of the said vehicles on the terms and conditions mentioned below. Scrap dealers / Persons / Firms interesting in purchasing the above mentioned vehicles may submit their highest quotations in the enclosed proforma in a sealed cover addressed to the undersigned latest by 5.00 P.M on or before ~~28.2.2021~~ <sup>04.03.2021</sup> through Registered Post/ Speed Post or courier. The in time received sealed quotations will be opened in the Chamber of the undersigned on ~~08.03.2021~~ <sup>04.03.2021</sup> at 3.00 P.M. The bidders or their representatives not more than one for each quotation, may be present, if they so desired, at the time of opening of in time received Quotations. The cover should be prominently superscripted with the words "Quotation for Purchase of Condemned Vehicle". No quotation will be entertained in any other forms except the approve Auction Call Notice Paper.
3. The vehicle will be available for inspection between 2.00 P.M to 4.30 P.M from ~~18.02.2021~~ <sup>03.03.2021</sup> to ~~27.02.2021~~ <sup>04.03.2021</sup> except holidays in presence of OIC Vehicle, Berhampur University. The vehicles are lying inside the campus of Berhampur University.
4. The Auction Sale of the said vehicles will be governed by the following conditions:-
  - i) The Quotationer are expected to be fully conversant with the meaning of all the clauses of the Auction Sale before submission.


- ii) The vehicles will be sold on "As in where is basis". The auction process will be conducted in presence of committee by following OUAM-1987 Rules.
- iii) The bidders are required to pay earnest money of Rs.20,000/- (rupees twenty thousand) only for the said vehicle.
- iv) Earnest Money (refundable) is to be deposit by means of Demand Draft drawn in favour of Comptroller of Finance, Berhampur University, Bhanja Bihar payable at SBI, Bhanja Bihar(IFS Code-SBIN0002107).
- v) A non-refundable amount of Rs.1,000/- (rupees One thousand) only through DD or Bankers Cheque is required to be submitted by the bidder towards Cost of Auction Sale Notice paper. The said amount is to be drawn in favour of as mentioned above.
- vi) The EMD and Auction Sale Notice paper cost payment made by cheque or cash shall not be accepted.
- vii) Quotation received without Demand Draft / Bankers cheque towards EMD and quotation paper cost will not be considered and shall be rejected.
- Viii) The successful bidder will be required to deposit the full bid amount by means of D.D or B.C drawn in favour of Comptroller of Finance, Berhampur University payable at SBI (2107), Bhanja Bihar, within seven working days of the acceptance of bid.
- Ix) The earnest money of the successful bidder will be released only after the deposit of the full bid amount, lifting of the vehicles in scheduled days and full time of all requisite conditions. Earnest money will not be adjusted as bid amount, and will be forfeited, if he / she / firm fails to honour the bid. In case of failure to deposit final bidding amount, the respective may once again taken up for re-auction. The EMD of the quotationer except the 1<sup>st</sup> three highest bidders will be refunded after 15 days from the date of opening of the quotation. The EMD of the 2<sup>nd</sup> and 3<sup>rd</sup> highest quotationer will be refunded only after deposit of full amount by the successful (1<sup>st</sup> highest) quotationer.
- X) The successful bidder will be responsible for future legal matters whatsoever pertaining to the vehicles after taking delivery.
- xi) The successful bidders are liable to pay MV Tax, VCR etc., if any, outstanding against vehicles.


- xii) The GST and Service Taxes, if any, applicable will be borne by the bidders as the GST to be paid by the recipient in accord once to the prevailing GST Rules.
- xiii) An affidavit regarding scraping of vehicles from the First Class Magistrate will have to given before taking possession of the vehicles and original cut part of chassis number of vehicle should have to be submitted to the Office of OIC, Vehicles, Berhampur University for necessary action and a letter will be sent to the Transport Authority to cancel the registration of the vehicle.
- xiv) The delivery of the auctioned vehicles will e arranged only after successful bidder submits documentary evidence in support of residential status (PAN Card, Aadhar Card. Etc. in case individual and Registration Certificate along with PAN card/ Udyog Aadhar etc. in case of firms / companies.
- xv) The bidders who desires to submit the quotation by downloading Auction Sale Notice Paper from website [www.buodisha.edu.in](http://www.buodisha.edu.in) is required to submit non-refundable DD/B.C. of Rs.1,000/- (Rupees one thousand) only towards cost of Auction Sale Paper.
- Xvi) The authority reserves the right to accept / reject any or all quotations without assigning any reason thereof. No complain will be accepted after finalization of the quotation.
- xvii) Quotation should be offered in Proforma prescribed as given at "Annexure"
- xviii) This office will not have any responsibility for transfer of vehicles and for any other liabilities for using these vehicles for commercial / private or any other purpose after sale. This clause should be appended in the afore mentioned affidavit.
- xix) The bidders will not be allowed to withdraw their bids, under any circumstances, otherwise, the Earnest Money will be forfeited.
- xx) Rates should be quoted both in figures and words.
- xxi) Any correction, overwriting etc. should be avoided. Correction where unavoidable should be made by rewriting with dated initials after coming out the wrong entries.
- xxii) In case of variation between figures and words the rates quoted in words will be taken into consideration.



- xxiii) The quotation offered by bidder will be considered to be valid for a period of 120 days from the opening of quotation. Confirmation regarding extension of time of the quotation will be asked from the bidder if further extension is required.
- xxiv) Rates quoted if found low is subject to negotiation for increasing the rates. The bidding price is below the reserve price it will not considered.
- xxv) On receipt of the lifting order the quotationer would acquire the vehicle from the Officer-in-Charge, Vehicle, Berhampur University through indent and gate pass etc. observing all official procedures. It will be the sole responsibility of the quotationer to look after the vehicle and its compatible items at his/her own cost. The University Office will not held responsible for any damage by way of pilferage or any other unforeseen calamities and no claim on this account shall be entertained. The auctioned vehicles must be removed by the successful bidder within 07 days from date of lifting order issued at his / her cost. If the quotationer are not lifted the auctioned vehicles fully or partly within 7 days from the date of lifting order issuance, ground rent penalty @1% of bid amount per day will be charged extra for further period of 30 days and there after the entire amount paid by him will be forfeited and the bidder will have no rights on the auctioned vehicle.
- xxvi) The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.
- xxvii) The successful bidder shall not sublet the whole or part of the auctioned vehicle.
- xxviii) Suit if any arising out of the auction are subject of jurisdiction of Odisha High Court, Cuttack.
- xxix) Tendering form should be signed in ink or ball pen by the authorized signatory only. Photocopy or unsigned or quotation not signed by authorized signature shall be rejected.


